

www.lifechurch.tv Terms of Service

1. Acceptance of Terms

LifeChurch.tv provides services on the Internet and the World Wide Web (the "Web") through its web site <http://www.lifechurch.tv>, subject to the following TERMS OF USE. LifeChurch.tv may update the TERMS OF USE from time to time, without notice, and maintains the most current version of these TERMS OF USE at: <http://www.lifechurch.tv/terms.php>. When using the LifeChurch.tv site, you will also be subject to any additional guidelines or rules which may be posted from time to time on the LifeChurch.tv site. All such guidelines or rules are hereby incorporated by reference into these TERMS OF USE. Violations of these TERMS OF USE should be reported via email to legal@LifeChurch.tv.

2. Description of Service

LifeChurch.tv provides Users with access to a variety of services through the LifeChurch.tv site, including but not limited to, online video viewing, personalized content, and downloadable resources at no charge to the end user. By using the LifeChurch.tv site, you understand that such usage may include communications from LifeChurch.tv, including but not limited to service announcements, administrative messages, and other messages to which you have individually subscribed. You understand and agree that you are responsible for obtaining access to the LifeChurch.tv site, which may involve equipment and third-party fees (such as Internet service provider fees, airtime charges, or other charges associated with the display and delivery of messages).

3. Your Registration Obligations

You acknowledge and agree to provide true, accurate, current and complete information about yourself as prompted by The LifeChurch.tv site's registration form(s) (the "Registration Data"). 5. Member Account, Password and Security

Upon completing LifeChurch.tv's registration process, you will receive a password and account designation. You are responsible for maintaining the confidentiality of the password and account, and you are fully responsible for all activities that occur under your password or account. You agree to (a) immediately notify LifeChurch.tv of any unauthorized use of your password or account or any other breach of security, and (b) ensure that you exit from your account at the end of each session.

6. Member Conduct

This means that you, and not

Although LifeChurch.tv does monitor Content submitted to www.lifechurch.tv, LifeChurch.tv cannot reasonably guarantee the accuracy, integrity, quality, or suitability of such Content. 9. disrupt the normal flow of dialogue, or otherwise act in a manner that negatively affects other users' ability to engage in real-time exchanges;
10. interfere with or disrupt www.lifechurch.tv or servers or networks connected to www.lifechurch.tv, or disobey any requirements, procedures, policies or regulations of networks connected to www.lifechurch.tv;
11. intentionally or unintentionally violate any applicable local, state, national or international law, including, but not limited to, regulations promulgated by the U.S. Securities and Exchange Commission, any rules of any national or other securities exchange, including, without limitation, the New York Stock Exchange, the American Stock Exchange or the NASDAQ, and any regulations having the force of law;

If any provision of these TERMS OF USE is found by a court of competent jurisdiction to be invalid, the parties nevertheless agree that the court should endeavor to give effect to the parties' intentions as reflected in the provision, and the other provisions of these TERMS OF USE remain in full force and effect. **No Right of Survivorship and Non-Transferability.** You agree that your LifeChurch.tv account is non-transferable.
